FOR INTERESTED PERSON STATUS UNDER 24 V.S.A. SECTION 4465**

WHEREAS under 24 V.S.A. Section 4465(b)(4), “Any ten persons who may be any combination of voters or real property owners within a municipality listed in subdivision (2) of this subsection who, by signed petition to the appropriate municipal panel of a municipality, the plan or a bylaw of which is at issue in any appeal brought under this title, allege that any relief requested by a person under this title, if granted, will not be in accord with the policies, purposes, or terms of the plan or bylaw of that municipality.
