Pursuant to notice the Board of Civil authority of the Town of Halifax, Vermont, met Wednesday, July 14, 2021 at 7:00 P.M. at the Town Clerk's Office to act on the following business:

The meeting was called to order at 7:04 P.M. the following members were in attendance: Patricia Dow, Craig Stone, Lewis Sumner, Patricia Pusey, Brad Rafus and Peter Silverberg.

Elect a Chairman: Patricia Dow nominated Craig Stone and the motion was seconded by Patricia Pusey. The motion was so voted and passed.
