The legal voters of the Town of Halifax, Vermont are hereby warned and notified to meet in the Elementary School Library, 246 Branch Road in said Town on Tuesday August 13, 2024, to vote the following articles by Australian Ballot:

Polls open from 10:00 AM to 7:00 PM

Article 1: To elect by Australian Ballot all Town Officers required by law to fill all vacancies.

<u>OFFICE</u>	<u>TERM LENGTH</u>	<u>TERM EXPIRATION</u>
Selectboard	remainder of 3 yr.	Term expires 2026
Auditor (to stagger years of election)	3 years	Term expires 2027
Auditor (to stagger years of election)	2 years	Term expires 2026
Auditor (to stagger years of election)	1 year	Term expires 2025

(Normal auditor term is a 3-year position for all 3 seats)

Article 2: Shall the voters authorize purchase of a highway equipment fleet excavator in an amount not to exceed \$350,000 to be financed over a period not to exceed 15 years?

Article 3: Shall the voters authorize purchase of a highway equipment fleet loader in an amount not to exceed \$235,000 to be financed over a period not to exceed 15 years?
